HALF DAY MORNING SESSIONS (9:15-12:30)

Hazard Communication* OCOSH ^- Sarah Ghezzi, BWC, offers practical ways to implement the hazard communication standard for general industry, construction and public sector, program requirements, training topics 29 CFR 1910.1200, labeling, MSDSs, and new requirements for the Global Harmonization System.

Accident Analysis Workshop* OCOSH ^- Jerry Palfy, BWC, for those who need basic awareness, are newly appointed, have limited exposure or need a refresher, learn info and tools to establish and improve accident analysis, causal factors, action steps to analyze, and tools to improve accident analysis programs.

Required Annual Hazardous Waste Training For Large Quantity Generators - Karen Nesbit, OEPA, gives overview of applicable generator hazardous waste rules, rule updates, new rules on horizon. All types of generators will also benefit from training.

SESSION A (9:15-10:15)

Basic Oil & Gas 101 Pt 1: Exploration & Drilling ^- Charlie Dixon, OOGEEP, covers the process by which oil and gas forms, migrates and is trapped in rock and technologies used to explore, drill, produce, and refine it.

Transitional Work Grant & Bonus Programs - Tina Elliott, BWC, use BWC Transitional Work Grant to help injured workers remain at or return to work, develop a tailor-made program for your company, get incentives for quickly and safely bringing workers back in a modified capacity while allowing them to recover from injury.

Intro to Effective Claims Medical Management - Cheryl Altizer & Dianne Lindsay, Comp One MCO, helps you align claims management to company objectives, management philosophy, and workplace needs.

Trench & Excavation^ - Dennis Hobart, Baker Corp., knows the success of the project and employee safety depend on making the right trench safety decisions. From planning and installation to removal, learn to build efficient shoring solutions to match the specific job requirements.

Workplace Chemical Hazards—How to Prepare and Report - Willie Brantingham, IC Columbiana County LEPC, Chief Winona FD, helps you determine, understand, and report chemicals in your workplace and have a contingency plan in case of an accident or spill. Also covers OH EPA regs for reportable HS and EHS chemicals.

BWC's Destination Excellence - Erwin Grabisna, BWC, describes how you can select from a cafeteria plan of 7 new and existing options to meet your needs. Prevent injuries and get injured workers back to work sooner to save money and increase the chance of a positive outcome for injured workers.

SESSION B (10:30-11:30)

Basic Oil & Gas 101 Pt 2: Well Stimulation & Production ^- Charlie Dixon, OOGEEP, explains the next steps in the development process.
Transitional Work Plan Workshop - Tina Elliott, BWC, shows how to return injured workers safely before 100% recovered, create plan using BWC templates and forms. Bring a copy of your company plan to review eligibility for bonus or ask questions.

Reducing Injuries When Using Power Tools at Work or Home ^- Kent McGuire, OSU Extension Office, says tools are part of everyday life and most industries, helping us easily perform tasks. However, simple tools can be hazardous and have potential for causing severe injury when used or maintained improperly.

OSHA Update ^- Howie Eberts & Julie Weis, OSHA, describe what you should know about OSHA for 2012 and beyond—regulatory changes, frequently cited standards, how fines and citations are handled, increased OSHA inspections, and specific industry changes.

Lift Plans That Remove the Risk Pt.1 ^- Al Abel, Mazzella Lifting Technologies, deals with planning a lift from start to finish. Each participant will plan a lift and review the inspection criteria called out by the ASME B.30 standard.

Explosive Dusts Prevention & Protection ^- Tom Kling, Corrosion Fluid Products, presents techniques for preventing dust explosions and protecting people and facilities from their effects. Shows how to adopt a systematic approach to dust explosion hazards assessment based on safe process.

HALF DAY AFTERNOON SESSIONS (1:15-4:30)

Violence in the Workplace* OCOSH ^- Bob Fioritto, BWC, identifies the potential for and prevention of workplace violence, a leading cause of fatal injuries at work. Assault, robbery, harassment, intimidation, threats of harm, sabotage, and domestic violence spillover: causes, early warning signs, prevention strategies, and elements of a plan.

OSHA Recordkeeping* OCOSH ^- Scott Turner, BWC, gives basic info for safety directors and committee members on OSHA requirements for recording workplace injuries and illnesses, correct use and completion of OSHA recordkeeping forms including 300, 300A, and 301, and regulation 1904 scope and responsibilities.

SESSION C (1-2)

Oil & Gas BWC Safety & Risk Services^ - David Loughner/Ron Kruchan/Christine Williams, BWC, tell how real change starts at the top. Successful safety efforts depend on employer commitment, involvement and support. Get knowledge, tools and skills to prevent injuries/illnesses and make employee safety part of your business operation.

Methamphetamines in the Workplace^ - Dennis Lowe, OH Bureau Criminal Investigation, gives plenty of reasons meth in the workplace is a bad thing. Two should get your attention: 1. Meth is bad for business and your bottom line. 2. Meth is bad for employee health and safety. Find out what to do.

Developing Your Emergency Operations Plan - Vikki Bunting, Field Liaison Ohio EMA, MEP, offers fundamentals of the emergency planning process and rationale behind planning. Get tips to develop a new plan or refine an existing one.

Distracted Driving & Employer Policies ^- Larry Kingston, National Safety Council, Northern Ohio Chapter, explains the dangers of cell phone use while driving and actions employers can take to make our roadways safer by implementing comprehensive cell phone policies.

Lift Plans That Remove the Risk Pt. 2 ^- Al Abel, Mazzella Lifting Technologies, provides interactive classroom inspection of various types of rigging gear. Reviews the inspection criteria for hardware, slings, and below the hook lifting devices per ASME B30 standard.

How to Qualify for No Exposure Under the Storm Water Program - Adrienne LaFavre, OEPA, reviews No Exposure Certification, how to complete the form, what the 11 qualifying questions mean, and benefits of No Exposure over a storm water permit.
